I.R.S. Offers \$1,000 Bonus

If you are at least 18 by December 31st, are not a student and are not claimed by someone else as a dependent, you will get a tax credit for 50% of the first \$2,000 you put into an IRA if your adjusted gross income is under \$15,000 (\$22,500 for head of household and \$30,000 on a joint return).

This is a non-refundable credit to be used to pay your income tax. Many of our children are eligible for this credit, in addition to the refundable earned income credit. A 20% or 10% credit is available on incomes up to \$25,000 (\$37,500 head of household; \$50,000 joint). Don't miss this if you're eligible - it's free money!
